

Rules of the Conference Recent advances in classical algebraic geometry 2022 ("Regulations")

§ 1 Time and duration

1 These Regulations define the rights and obligations of participants in the scientific conference in the field of algebraic geometry entitled „Recent Advances in Classical Algebraic Geometry 2022”, financed by the Education and Science Fund program as part of the „Excellent Scientific Award” (Hereinafter the „Event”), on the basis of a contract for the implementation of the project „Recent Advances in Classical Algebraic Geometry” (Hereinafter the "Project"). The event will be held from June 28, 2022. until July 2, 2022 in a hybrid form, i.e. online via the internet streaming platform Microsoft Teams (hereinafter referred to as the "Platform") and stationary in Krakow, in the following locations:

a) The Faculty of Mathematics and Computer Science of the Jagiellonian University, ul. prof. Stanisława Łojasiewicza 6, 30-348 Kraków;

b) Museum of the Jagiellonian University Collegium Maius, ul. Jagiellońska 15, 31-010 Kraków;

c) a restaurant where the conference dinner will be held - the name and address of the restaurant will be communicated to the participants of the Event on the first day of the Event.

The Jagiellonian University reserves the right to exclude the locations indicated in point a) -c) above from visits by participants or their change, upon prior notification of participants made via e-mail sent to the address provided by the participant during registration and by posting information on the website of the Event, referred to in par. 4.

2 The organizer of the event is the Jagiellonian University with its seat in Krakow at ul. Gołębia 24, 31-007 Kraków (hereinafter referred to as the „Organizer”).

3 The organization of the Event is supervised by the Organizing Committee (hereinafter referred to as the "Organizing Committee"), and scientific supervision over its course is exercised by the Scientific Committee of the Event (hereinafter referred to as the "Scientific Committee") appointed by the Organizer.

4 The Regulations of the Event are made available to the Participants on the website <http://racag22.c.matinf.uj.edu.pl> (hereinafter referred to as the "Event Website"), in Polish and English, in a way that allows them to be downloaded and will also be displayed before at the entrance of the building of the Faculty Mathematics and Computer Science of the Jagiellonian University.

5 Detailed information about the Event and its program can be found on the Event Website.

6 During the Event, Participants will be made available to forms of activity prepared for them, which will be defined by separate programs. The curricula referred to in the preceding sentence will be posted on the Event Website and in the Event participation registration system.

7 The organizer reserves the right to make changes to the program of the Event, including changes to the schedule and sequence of lectures. In the event of changes, the Organizer will inform about it immediately on the Event Website.

8 The Organizer reserves the right to change the Regulations due to a change in generally applicable law and the need to adapt the Regulations to this change, in particular in order to adjust the formula of the Event to the restrictions, orders and bans related to the introduction of a pandemic state, change of the Event program, increase of security measures accompanying the Event. The amendment to the Regulations will come into force within 7 days from the date of its publication on the Event Website. For Participants who have accepted the Regulations, the change will come into force within 7 days from informing them about the change in the Regulations and not expressing any objection to this change in the above-mentioned time limit.

9 The organizer reserves the right to change the date and formula of the Event if its organization on the date or in the form referred to in paragraph 1 above will be impossible or excessively difficult for reasons beyond the control of the Organizer, in particular due to restrictions, orders and bans related to the introduction of a pandemic state. The change of the date and/or the formula of the Event will be immediately announced on the Event Website.

§ 2

Registration of participation in the Event

1 The Participant of the Event is any adult person with full legal capacity, conducting research in the field of algebraic geometry, who by April 30, 2022, has applied for participation in the Event in the manner referred to in this paragraph, has accepted the rules of participation in the Event indicated in the Regulations and was approved by the Organizing Committee (hereinafter referred to as the „Participant“). The decision of the Organizing Committee is final and may not be appealed against.

2 Young mathematicians (up to 10 years after obtaining a doctoral degree) who apply for in person participation in the Event may apply for financial support (hereinafter referred to as "Grant"), covering part of the costs of stay in the amount of up to PLN 300 for each night and part of the costs travel up to PLN 1,000 for participants from Europe and up to PLN 3,000 for participants from outside Europe. The Organizing Committee, after consultation with the Scientific Committee, will select 30 beneficiaries of the Grant on the basis of substantive criteria, i.e. the quality of the candidate's scientific achievements, age, area of interest and affiliation, and will determine the amount of the Grant awarded to each of them. Detailed rules for awarding the Grant will be made available by the Organizer on the Event Website. The decision of the Organizing Committee is discretionary, determined by the Project requirements, the candidates will be notified by e-mail by 30/04/2022. The decision of the Organizing Committee is final and may not be appealed against.

3 The Grant will be transferred to the beneficiaries selected by the Organizer in a manner which is compliant with the internal rules of the Organizer. The Grant Beneficiary might be obliged to provide the Organizer with the following data necessary to carry out the process of payment/transfer of the Grant: bank details (in particular bank account number), address, ID number. The condition for the payment of the Grant is the actual in person participation of the Grant beneficiary in the Event and the completing of formalities related to the payment/transfer of the Grant that will be indicated on the Event website. Persons who have been awarded a Grant and who have not participated in the Event and/or have completed formalities mentioned above, lose the right to the payment of the Grant and are not entitled to any claims against the Organizer in this respect.

4 Participation in the Event is free of charge and requires prior registration through the registration form (hereinafter referred to as the "Form") available on the Event Website, in which a person wishing to participate in the Event will be required to provide the following data: name and surname, address e-mail, affiliation. In the case of people interested in participating in the Event, applying for a Grant, the Form should additionally include the following data: curriculum vitae with a list of publications, which include information necessary to select grant beneficiaries.

5 Registration of participation in the Event will start on February 03/03/2022 at 00.00 and will last until 30/04/2022. In the case of Participants applying for the Grant registration of participation will last until 30/03/2022. A detailed method of registering participation in the Event and registration dates are provided on the Event Website.

6 In the event of resignation from participation in the Event, the Participant is obliged to immediately inform the Organizer by sending relevant information to the e-mail address: racag22@uj.edu.pl.

7 Participation in the Event may take two forms (hereinafter referred to as "Participation Forms"):
a) online, i.e. in real time, via the Platform designated by the Organizer, to which the registered Participant will gain access via a link sent to him by e-mail (hereinafter referred to as the "Online Form" or, respectively, the "Online Participant");

b) in person, by the Participant showing up at the place where the Event is organized (hereinafter referred to as the "Form of personal participation" or, respectively, the "Stationary Participant").

The Participant shall choose one of the Participation Forms in the Event by checking the appropriate box in the Form. / Form of participation for individual Participants:

- a) in person - Form of personal participation
- b) online - Online form.

8 Using the Form, the Participant may declare their willingness to participate in the events accompanying the Event, i.e. the dinner, which will take place on June 29, 2022 (hereinafter referred to as "Dinner"), at the restaurant referred to in § 1 section 1 point c) of the Regulations.

9 Participation in the Event is possible on the basis of prior registration, but this does not apply to activities that in the Event's program have been marked with the annotation "no registration", and which may also be attended by people who have not registered for participation in the Event. The organizers reserve the right to allow unregistered people to participate in the Event, after prior approval of the provisions of the Regulations, if this will serve the main objectives of the Event, i.e. popularizing science and tightening international cooperation, and if the rules of the sanitary - epidemiological regime in force at the time of the Event do not contradict it.

10 The Organizer is not responsible for the Participant providing incorrect or false data when registering for the participation in the Event.

11 The following limits apply:

- a) The Event in online form may be attended by a maximum of 100 Participants;
- b) The Event in the form of in person participation may be attended by a maximum of 100 Participants;
- c) The Dinner may be attended by a maximum of 100 Participants (hereinafter referred to as "Dinner Participants").

After reporting the will to participate in the Event in a given Form, the applicant will receive an e-mail from the Organizer informing about his qualification or non-qualification for participation in the Event and/or at the Dinner. The participants of the Event will be selected based on the substantive criteria resulting from the assumptions of the Project.

12 Indicated in sec. 10 above, the limits for participants of the Event and Dinner may change due to the epidemiological situation during the Event and related restrictions, orders and prohibitions. The Organizer will immediately notify about the change of the limits on the Event Website. If it is necessary to limit the number of Participants of the Event and/or Dinner, the Organizer, within the limits available and the will to participate in the Event expressed by the Participants via e-mail, will re-qualify Participants, taking into account the previously sent data. The Organizer will inform by e-mail the Participants who will not be able to participate in the Event and/or Dinner due to the change of limits.

13 Participation in the Online Form requires the Participant to have an ICT system that meets the following minimum technical requirements:

- Internet access;
- terminal device;
- software that allows you to read files in various formats (including text, sound, graphics, multimedia, video, etc.);

14 The Participant confirms that he has read the Regulations and accepts the provisions of the Regulations, which is tantamount to granting by the Participant the permits, licenses and authorizations referred to in the Regulations, and in the case of speakers and participants presenting posters as part of the poster session - is an obligation to conclude with the Organizer the agreement referred to in § 6 sec. 4 of the Regulations. Registration of participation in the Event and/or Dinner is made at the moment of filling in the Participant's data in the Form and sending it by the Participant together with the consents referred to in § 5-9 of the Regulations, using the Form on the Event Website and confirmation by the Organizer of participation in the Event.

15 The Participant acquires a place to participate in the Event and/or Dinner upon receipt of confirmation of acceptance of registration by the Organizing Committee.

16 By participating in the Event, the Participant agrees to make his name and affiliation available on the Event Website.

§ 3

Rules for participation in the Event

1 During the Event, there will be lectures by Participants asked by the Organizer to deliver a lecture and also contributed lectures selected from propositions by Participants who notify the Organizer of their will to deliver a lecture, pursuant to the provisions of § 5 sec. 1 and 2 of the Regulations (hereinafter referred to as "Lectures"), there will also be a poster session (hereinafter referred to as the "Session"). The event will be conducted in English.

2 Each online Participant during the Event has the right to submit questions via the chat available on the Platform's website. From the questions submitted, the chat moderator will choose those that will be asked to the speakers. After the end of the Lecture, an in person participant may declare the will to ask questions by raising his hand. The organizer, taking into account the planned duration of the Lectures, as well as the schedule of the Event, will decide on the number of questions and their content.

3 The course of the Event, including both the Online Form and the Form of Attendance, will be recorded in the form of a photo report (hereinafter referred to as the "Photo Report") and an audiovideo recording (hereinafter referred to as the "Recording"). Until 30/06/2023, on the website <http://racag22.c.matinf.uj.edu.pl/>, the Organizer will make the Recording available to an unlimited circle of recipients.

4 The Event Organizer, by providing Participants with conference materials (hereinafter referred to as "Conference Materials"), pays special attention to the necessity to respect intellectual property rights by the Participants. Participants undertake to use the Conference Materials provided to them by the Organizer only for their own personal use. Modifying, copying, sending, public performance and any use of these Conference Materials for commercial purposes requires prior written consent by the Organizer or by another authorized entity. Participants are fully liable for any damage caused as a result of their behavior contrary to the above reservation.

5 Participants accept the established rules of the Event and its program, and undertake not to influence its change and not to disrupt the course of the Event. The Organizer is entitled to exclude from participation in the Event Participants who violate the provisions of the Regulations, in particular:

- a) disrupt the course of the Event;
- b) undertake actions that are inconsistent with the law, morality, or against the legitimate interests of third parties;
- c) take actions aimed at circumventing or indicating an attempt to circumvent the Regulations or the rules of holding the Event;
- d) take actions that violate the legitimate interests of the Organizer or harm its image.

6 The Organizer of the Event is not responsible for:

- a) incorrect or malfunctioning software used by the Participant;
- b) lack or interruption of Internet access for reasons attributable to the Participant;
- c) defectiveness of the computer equipment used by the Participant;
- d) incorrect operation of the Platform by the Participant;
- e) other circumstances preventing or hindering participation in the Event, not caused by the actions or omissions of the Organizer.

§ 4

Rights and obligations of stationary participants and dinner participants

1 A stationary participant, upon arrival at the Event venue, is obliged to confirm his/her personal participation in the Event at the reception desk in a designated and marked place.

2 Stationary participants and Dinner Participants are required to comply with the safety, health and fire regulations in force at the premises where the Event and/or Dinner is organized, and the sanitary regime applicable at that time.

3 The Organizer is not responsible for items left and lost during the Event and/or Dinner and for items left in clothing or backpacks/handbags/suitcases left in the cloakroom, as well as in other public places on the premises of the Event, the Jagiellonian University and the restaurant where the Dinner will be held.

4 Event staff, in the event of a participant disturbing public order or failing to comply with the sanitary regime applicable on the day of the Event, is entitled to:

a) call the Participant to appropriate behavior;
b) request the Participant to leave the Event area;
c) call competent services in a situation where the Participant's behavior qualifies for such intervention, in particular when it poses a threat to other Participants or the staff of the Event or the Organizer's property.

5 The Organizer is not responsible for events resulting from the Participants' non-compliance with the Regulations, Participants' non-compliance with the Organizer's recommendations or the instructions of the Event staff or services responsible for security and order.

6 The organizer forbids smoking, drinking alcohol and taking intoxicants on the premises of the Event.

7 In order to ensure security on the premises of the Event, the Organizer may use monitoring covering the entire area of the Event, as well as its fragments. The rules for applying monitoring by the Organizer are set out in the Ordinance No. 34 of the Rector of the Jagiellonian University of May 16, 2019 on: Regulations of video monitoring at the Jagiellonian University and its later amendments, available in the Public Information Bulletin of the Jagiellonian University.

8 In the event of noticing a threat to the life and health of the Participants, the Participant is obliged to immediately inform the Event staff about it.

§ 5

Speakers, Participants presenting Posters

1 The Organizer will ask some Event Participants to deliver Lectures. The Participant who accepts the Organizer's request (hereinafter also referred to as the "Speaker") will send by 01/06/2022 to the Organizer to the following e-mail address by: racag22@uj.edu.pl, in the form of a digital text file, the author's abstract of the Lecture, which he intends to deliver during the Event (hereinafter referred to as the "Abstract").

2 The Participant of the Event, by registering via the Form, may declare willingness to deliver an original Lecture of 50 minutes, presenting the results of his research. The Organizing Committee, in consultation with the Scientific Committee, will conduct a selection for the needs of which it will ask people who have declared their will to prepare a Lecture, to send a short Abstract of the Lecture in the form of a digital text file. The organizer will notify the people whose Lectures have been selected via e-mail sent by 01/06/2022. From that moment on, the persons qualified to deliver the Lecture will be considered Speakers. The decision of the Organizing Committee to select Speakers, made on the basis of substantive criteria, is final and may be appealed against.

3 In order to illustrate the content of the Lecture, the Speaker may prepare an original presentation (hereinafter referred to as the "Presentation") in the form of a pdf file, which will be displayed during the Lecture and made available on the Event Website. The Speaker will inform the Organizer about the intention to use a Presentation by 15/06/2022, and by 27/06/2022, he will make the Presentation in pdf format available to the Organizer via e-mail.

4 The Participant of the Event, by registering via the Form, may submit a willingness to prepare an original poster presenting his research results (hereinafter referred to as the "Poster"). In the case of too many people willing to prepare the Poster, the Organizing Committee will conduct a selection for the needs of which it will ask those who declared their will to prepare the Poster to send a short description of the results that they intend to present on the Poster. The Organizer will notify the persons whose Posters have been selected via e-mail sent by 1/06/2022. The decision of the Organizing Committee on the selection of Participants presenting the Posters, made on the basis of substantive criteria, is final and may not be appealed against. The Participant will send the Organizer the final version of the Poster in electronic form, in pdf format, to the following address: racag22@uj.edu.pl, by 27/06/2022.

5 The Poster should be printed in a format no larger than A0 and delivered to the Session by the Participant. The session will take place in a designated and marked room in the building of the Faculty of Mathematics and Informatics of the Jagiellonian University, and its course may be recorded in the form of a video report (hereinafter referred to as "Video report") and Photo report.

6 The actions taken by the Participant referred to in sec. 1-4 above are an expression of granting the Organizer:

a) consent to post the name, surname and affiliation of the Participant on the Event Website;
b) granting the Organizer a non-exclusive, unlimited territorially, quantitatively and qualitatively license to use the Abstract, Presentation and/or Poster until the conclusion of the contract with the Organizer referred to in § 6 sec. 4 of the Regulations, which license covers the use of the Abstract, Presentation and/or Poster to the extent and in the fields of use referred to in § 6 sec. 4-6 of the Regulations, with the right to sub-license to third parties with a scope analogous to the scope of the license, for the purposes of preparing, organizing, conducting and settling the Event, preparing Conference Materials, including a book of abstracts, posters and for information, documentation and promotional purposes of the Organizer, Event and the Ministry of Science and Education.

7 Preparation of an Abstract, Presentation, Lecture and/or Poster and delivery of the Lecture, presentation of the Presentation, Poster, as well as granting the Organizer permits, authorizations and licenses and transferring the rights referred to in this paragraph and in § 6-8 of the Regulations, within the scope and in all the fields of use indicated therein, is free of charge and is performed for the statutory purposes of the Organizer.

8 Granting the Organizer permits, licenses, authorizations and transferring the rights referred to in this paragraph and in § 6-8 of the Regulations to the Organizer is voluntary, but necessary to present the Lecture and/or Poster.

§ 6 *Copyright*

1 The Participant is fully responsible for the form and content of the Lecture, Abstract, Poster and Presentation (hereinafter collectively referred to as "Works"). The Participant undertakes to develop and present original Works that will not infringe the rights and personal rights of third parties, contain theses and views inciting hatred or discrimination against any people on the basis of race, culture, ethnicity, religion, or gender. Moreover, it is unacceptable to propagate ideology and symbolism related to totalitarian regimes in the content of the Works.

2 If any part of the Works contain legally protected elements, the rights to which will not be in possession of the Participant, the Participant guarantees that he is entitled to use them to the extent necessary to develop the Works, deliver a Lecture, present a Presentation and/or Poster, make the Works available to the Organizer, give him/her licenses, permits and authorizations referred to in § 5 and 6 of the Regulations and to the transfer to the Organizer of rights to the Works, to the extent referred to in paragraph 4-6 below, as well as granting the Organizer the authorizations referred to in sec. 7 below, without the Organizer having to obtain additional approvals and permits. The participant guarantees that upon the conclusion of the agreement referred to in paragraph 4 below, he will transfer the above-mentioned rights to the Organizer and will grant him the authorizations indicated in the preceding sentence.

3 The Participant agrees to broadcast the Lecture and Presentation in real time using live streaming of the Lecture and Presentation, via the Platform, and for their recording by the Organizer or an entity acting on his behalf, in the form of a Record and Photo Report. The Participant also agrees to the recording of the Session by the Organizer or an entity acting on his behalf in the form of Video Report and Photo Report.

4 No later than on the day of the presentation of the Lecture/Poster, the Participant will conclude a written agreement with the Organizer, under which he will transfer to the Organizer - without time, territorial, quantitative and qualitative restrictions, proprietary copyrights to the Lecture, which will be recorded in the form of a Recording, Presentation and Abstract and/or Poster, together with the exclusive right to exercise derivative copyrights to the Works and the exclusive right to allow third parties to exercise these rights, in all fields of use referred to in art. 50 of the Act of February 4, 1994. on copyright and related rights, in particular in the following fields of use:

a) recording and reproducing in whole or in part by producing copies of the Works by any printing technique, magnetic recording, any graphic techniques and digital technique;

b) trading in copies on which the Works were recorded by placing them on the market, lending them or renting them;

c) disseminating through public exhibiting, displaying, and making the Works available to the public in such a way that everyone can have access to them at a time and place of their choice, in particular by saving them to a computer and placing them on the Internet, in particular on the website of the Ministry of Education and Science and on the National Digital Library POLONA website administered by the National Library - www.polona.pl, as well as live streaming;

d) use by placing on movable property or real estate;

e) creating and disseminating derivative works of the Works, including further projects / materials based on the Works, developing their different graphic, color or visual or spatial formats and using such derivative works to the extent and in all fields of use specified in this section

5 Upon acquiring copyrights to the Works, the Organizer will be entitled to transfer them to third parties - in whole or in part, and grant them a license to use the Works, with a scope analogous to the scope of the rights acquired by the Organizer, referred to in this paragraph.

6 The agreement referred to in par. 4 above will also include the transfer to the Organizer - without time, territorial, quantitative and qualitative limitations, the right to exclusive exercise of subsidiary rights to the Works, in all fields of use referred to in paragraph 4 above - including, in particular, the right to make changes to the Works and make elaborations on it, use and dispose of derivative works, compile Lecture Recordings and Video Report with other recordings in order to develop a report from the Event and use it in the scope referred to in paragraph 4-5 above and to exclusively permit third parties to exercise derivative copyrights to the Works.

7 The Participant allows the Organizer and entities authorized by him to exercise the Participant's copyrights to the Works, and undertakes not to exercise these rights towards the Organizer and entities authorized by him. This authorization is granted without any quantitative, qualitative, temporal or territorial restrictions.

8 The agreement referred to in para. 4 above will also include the transfer to the Organizer of the ownership of the carriers on which the Works were Recorded, free of charge for the statutory purposes of the Organizer.

9 Until the conclusion of the contract referred to in paragraph 4 above, the Participant undertakes in no way to encumber his proprietary copyrights and subsidiary rights to the Works, to transfer these rights to third parties, or to grant authorizations, permits, licenses to use them, except for the licenses referred to in § 5 of the Regulations or to transfer to third parties the ownership of the media on which the Works have been recorded or to make them available on the basis of other legal titles to entities other than the Organizer.

10 In the event that third parties submit claims related to these Works or their individual elements in relation to the Organizer or its legal successors or to entities authorized by it to use any of the Works (hereinafter referred to as "Authorized Works"), the Participant:

a) will release the Organizer and the Authorized Persons from the claims in question, to the extent to which he was obliged to obtain from third parties rights to legally protected elements, including proprietary copyrights and the right to exercise derivative rights to these Works and their individual elements, and to obtain permits, licenses from them and authorizations referred to in the Regulations and

b) will be fully liable for any damage suffered by the Organizer and/or the Authorized Persons arising from claims against them, referred to in this paragraph, including primarily, but not exclusively, damages related to claims for compensation for unlawful use of any of the Works or their individual elements.

§ 8

Consent for image processing

1 The organizer will record the course of the Event using sound and image recording devices in the form of a Recording and Video Report, and a Photo Report - for documentation (e.g. reports) and information purposes (in particular for making available on the Event Website and other websites of the Organizer and the Minister of Education and Science from information about the Event and its course), promotion (e.g. on the Event Website and other websites of the Organizer, its profiles in social media and on the website of the Minister of Education and Science), archiving (in the field of recordings and photo coverage) and educational and didactic purposes, i.e. broadly understood popularization of science and its results (also understood as supporting scientific cooperation and announcing research results, in particular in the National Digital Library POLONA website administered by the National Library - www.polona.pl) and for information and promotion of the Minister of Education and Science.

2 Each regular participant, including Participants who are Speakers, by declaring in the Form the willingness to participate in the Event in person, expresses his consent to the use of his image, unlimited in time, territory, quantity and quality, for the purposes indicated in paragraph 1 above, without the right to remuneration under the above title, in particular by:
providing his image in real time for the purposes of broadcasting the Event, via the Platform, using live streaming;
recording the Participant's image in the form of a Photo Report from the Event and in the Recording, and the use of this recording, processing, duplication and multiple dissemination of the Participant's image recorded in the above-mentioned manner without the need to approve them each time, to the extent and in a manner analogous to that referred to in § 6 sec. 4 of the Regulations, in particular on the Event Website, Platform, on the Organizer's and the Ministry of Education and Science's websites, on the National Digital Library POLONA website administered by the National Library - www.polona.pl and on other websites, on the Organizer's profiles in social media and on websites, at promotional events of the Organizer, for the purposes referred to in paragraph 1 above.

3 Each participant who expressed the desire to develop a Poster and present it during the Session, declaring such a will in the Form, expresses his consent for the use of his image unlimited in time, territory, quantity and quality, for the purposes indicated in section 1 above, without the right to remuneration under the above title, in particular by recording the Participant's image in the form of Photo Reports and Video Reports and the use, processing, duplication and multiple dissemination of the Participant's image recorded in the above-mentioned manner without the need to approve it each time, to the extent and in the manner analogous to the one referred to in § 6 sec. 4 of the Regulations, in particular on the Event Website, Platform, on the Organizer's and the Ministry of Education and Science's websites, on the National Digital Library POLONA website administered by the National Library - www.polona.pl and on other websites, on the Organizer's profiles in social media and on websites, at promotional events of the Organizer, for the purposes referred to in paragraph 1 above.

4 Turning on the online camera of the end device by the Participant is tantamount to granting the Organizer an unlimited in time, territory, quantity and quality consent to the use of his image, for the purposes referred to in paragraph 1 above, to the extent analogous to that referred to in sec. 2 points a) and b) above.

The participant declares that such a designation is in accordance with his wishes and does not infringe his rights.

9 The event may only be recorded and photographed by the Organizer. It is forbidden to record and take photos by Participants during the Event without the prior consent of the Organizer.

10 The organizer has the right to authorize other entities to use the image on the terms set out in this permit.

§ 9

Personal data

In accordance with Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC (General Data Protection Regulation, hereinafter the "GDPR"), the Jagiellonian University reports that

3 The Participant's personal data will be processed for the purpose of:

a) performance of the contract, the subject of which is the participation of Participants in a scientific conference in the field of algebraic geometry under the title "Recent Advances in Classical Algebraic Geometry 2022" (hereinafter referred to as the "Event"), as well as to register participation in the Event, i.e. pursuant to Art. 6 sec. 1it. b) GDPR, on the basis of a contract concluded by accepting the Regulations. 1 The Organizer reserves the right to cancel the Event, change its program and formula. The Jagiellonian University will announce the cancellation of the event on the Event Website, referred to in §1 sec. 4. The Organizer will not be obliged to the Participants of any compensation or compensation in this respect, or to reimburse the costs incurred in order to participate in the Event.

2 These Regulations have been drawn up in Polish and English. In the event of any discrepancy between the language versions, the Polish version will prevail.

3 In matters not covered by the Regulations, generally applicable provisions of Polish law shall apply.
